The Release includes any rights on the part of the undersigned to seek indemnity or contribution or to claim any liability from Sponsor for any and all claims of any nature which could arise from my participation in said show.

The undersigned warrants that no promises or inducements have been made or offered for this Release. The Release is executed without reliance on any statement or representation of Sponsor.

There is absolutely no agreement, understanding, or reservation not expressly stated herein; and that the sole consideration for the within Release is the right for the undersigned to participate in the Cross Road Tack Horse Show. This Release shall inure to the benefit of Sponsor, their heirs, successors and assigns. The undersigned agrees to indemnify and hold harmless, Sponsor from any and all claims, suits or demands made against them, their heirs, successors and assigns that may result from the undersigned's participation in the show.

Warning: Under Pennsylvania's Equine Activity Immunity Act (Act 38 of 2005) law an equine professional and equine activity sponsor is not liable for an injury to or death of a participant in equine activities resulting from the inherent risks of equine activities.

Any person who rides, drives or otherwise participates directly in equine related activities is regarded as a participant.

1. This show is open to anyone, but points will only be counted for IBRA members.
2. CASH ONLY day of show.
3. IBRA dress code for the day of the show. A long-sleeved western shirt and boots. Western hats optional. No ball caps
4. Roll-over option: Pay entry fees for both classes and only run once. Must be designated at time of entry.
5. Paybacks determined by IBRA rules.
6. Refunds given minus Office Fee.
7. If you cannot leave your dog at home, please keep it on a leash.
8. All Cross Road Tack Shows are run in accordance with current IBRA rules.
9. You may run as many exhibitions as you'd like, but each should be kept to 1 minute or less. Exhibition-only horses must register and pay office fee.
10. Added money: 4-D Open \$200 added, 3-D Youth \$100 added, 3-D Senior \$100 added
