

Cross Road Tack Horse Shows Rules & Info

1. Approved helmets are mandatory for all riders at all times while mounted and exhibitors are to be suitably attired. Formal attire is not required.
2. Management reserves the right to divide, combine, cancel or change the order of classes if necessary. Judge's decision is final.
3. Negative coggins within one year required.
4. Six ribbons will be awarded in each class, with ribbon to the division champion and reserve. Year End Awards will be awarded at the April Show. Exhibitors must participate in at least 4 out of 7 shows to qualify for Year-End Awards.
5. SORRY NO DOGS ALLOWED!
6. All Cross Road Tack Shows are run in accordance with current USEF rules.
7. There is a \$5 grounds fee per horse showing, and \$15 for Non-Showing Horses.

The undersigned warrants that no promises or inducements have been made or offered for this Release. The Release is executed without reliance on any statement or representation of Sponsor.

There is absolutely no agreement, understanding, or reservation not expressly stated herein; and that the sole consideration for the within Release is the right for the undersigned to participate in the Cross Road Tack Horse Show. This Release shall inure to the benefit of Sponsor, their heirs, successors and assigns. The undersigned agrees to indemnify and hold harmless, Sponsor from any and all claims, suits or demands made against them, their heirs, successors and assigns that may result from the undersigned's participation in the show.

EQUITATION: Rider judged on hands, seat and control of mount.

HUNTER: Horse judged on manner performance and way of going.

DIVISION DEFINITIONS

LEADLINE - Open to riders 7 and under as of Jan. 1, of current year. May cross enter into Mini Stirrup ONLY.

MINI STIRRUP EQUITATION - Open to all riders 9 and under as of Jan. 1, of current year.

OPEN W/T EQUITATION - Open to riders of all ages. (Divided by age group if over 4 per age group)

SHORT STIRRUP EQUITATION - Open to riders 11 and under as of Jan. 1, of current year.

BEGINNER RIDER EQUITATION - Open to riders of all ages in their first or second year of showing.

DEVELOPING HUNTER - Open to horses and ponies in their first or second year of showing. May trot on course.

18" HUNTER - Open to riders of all ages. Horses and Ponies. (Divided by age group if over 4 per age group)

PLEASURE HORSE/PONY (2'/2'3") - Open to horses and ponies. (2'-Pony & 2'3"-Horse) (Horses & Pony's Split for 4 or more of each)

GREEN HUNTER - Open to horses and ponies in their first or second year of showing. May trot on course.

MODIFIED HUNTER (2') - Open to horses and ponies.

OPEN EQUITATION (2') - Open to all Riders, judged on hands, seat and control of mount.

LOW HUNTER (2'6") - Open to horses and ponies.

LOW CHILD/ADULT HUNTER (2'6") - Open to horses and ponies. (Divided by age group if over 4 per age group)

CROSS ROAD TACK MEDAL (X-rail, 2', 2'6") - Open to riders of all ages. Judged on hands, seat and control of mount. (Run as an open card at each height) (Must declare Medal round at gate)
